FIGHTERS CUP T15- 2019 Playing Conditions

1. Teams registered with the Fighters cup 2019 will have to abide by players and teams rules and regulations amended by Fighters CC
2. In case of violations of rules and regulations the organizers are entitled to disqualify the teams / players from the tournament.
3. The registrations are on first come first serve basis.
4. The registration amount is 45 BHD has to be paid during captains meet.
5. Once the registration formality is completed and if the teams want to back out then the amount will not be refunded.
6. Player registered under one team won't be able to participate from other team during the period of tournament.
7. In case of dispute during the passage of play the complete authority to take the final decision will reside with umpires. No other objections will be entertained by the organizers.
8. Each Team needs to fill up and submit the Team Registration Form and also have all their Players complete and submit the Players Registration Form with passport copies / CPR Copies
9. 24 teams will be participating in the tournament. In Round A, the teams will be grouped into 4 groups of 6 teams. Each team has 5 matches in round A.
10. The organizers will produce the tournament format before 5 days of tournament.
11. The organizers will announce the match time along with the schedule.
12. Each team has 3 matches umpiring on league matches .there will be a schedule for umpiring also.
13. If the team is not ready to attend the umpiring 2 points will be deducted.

14) LEAGUE CUM-KNOCKOUT BASIS

- a) The tournament will be played on a round robin cum knockout basis.
- b) 24 teams divided will be into 4 groups (A,B,C,D) comprising of 6 Teams each and teams in each group will play against each other on a round robin basis.
- c) Top 3 teams from each group scoring maximum points at the end of round robin matches will qualify for the knock out Pre-Quarter-final stages

15) POINTS SYSTEM - LEAGUE STAGE

- Match Won - Two points
- Match lost - No Points
- Match Abandoned (any reason) - One point to each team
- Match Tied - One point to each team
- Match cancelled - No point
- Match Forfeited due to Walk Over - Minus Two Points as Penalty for Walkover
- Umpiring points-Minus 2 points if not attend scheduled umpiring

16) NUMBER OF PLAYERS

A match is played between two sides and each side shall consist of 11 players. One of whom shall be a Captain. A Maximum numbers of 18 players can be registered under 1 team. A Match can start with minimum of 9 players. Players can be registered up to end of league stages only. Players cannot be changed for any reason once the knock out matches start. No player shall be allowed to be added once the knockout match starts.

17) SUBSTITUTES AND RUNNERS

If a fielder fails to take the field with his side at the start of the match, umpire will allow the player by the 3rd over. After 3 overs no players shall be allowed in the fielding squad.

18) THE BAT AND BALL & PITCH

New or used hard tennis cricket ball are supplied equally to both teams. Batting team can select optional balls supplied by the umpires. Team should bring their own bat & 1 set stumps. Fiber bats & srilankan made bats are not allowed to use. All matches will be conducted in Busaiteen.

19) NUMBER OF OVERS

A match will consist of one innings per side, each innings being limited to a maximum of 15 overs. One Bowler can bowl 3 overs maximum.

20) OTHER RULES AND REGULATIONS

- 1) No LBW wicket; Wide, No ball, Leg bye and over throws included.
- 2) First 5 overs POWER PLAY-only two players allowed outside the circle.
- 3) Only Captain and Vice-Captain have the right to speak with umpire or organizers.
- 4) Tournament format will be finalized in the captains meeting prior to the tournament (Date to be finalize shortly)
Winner will be awarded with Trophy and cash prize of 400USD, 1st Runners up will be awarded with Trophy and 200USD and Man of the Match in the final, Best batsman, Best bowler & Man of the series will be awarded with a trophy each.
- 5) Wicket keeper should field one over before he bowl an over.
- 6) There will be free hit only for Overstep No-ball
- 7) Balls pitching outside the concrete pitch shall be considered as a dead ball.

21) - No- Ball

No-ball will be given if:-

1. The umpire shall ascertain whether the bowler intends to bowl right handed or left handed, over or around the wicket, and shall so inform
2. A ball bounces over the batsman's head when he is standing upright in his normal position.
3. The ball does not touch the ground in its flight between the wickets and reaches the batsman at a height above his waist when he is standing in his normal position. Note: If a person has come out of the crease considerably, the rules for no Balls do not apply.
4. If the players found talking/ the fielders moving side by side while the bowler is taking run-up while bowling. One warning will be given by the umpire in a match. Next will be no-ball
5. Back leg of the bowler should not touch the side line.
6. A fielder is not allowed to stand in line with the bowler or the wicket keeper, in such an event the umpire shall call it a NO-BALL.

7. During power play, only 2 fielders are allowed to stay outside the circle and after the power play maximum 5 fielders- if it's against this rule also the umpire can call as no ball

8. Maximum 5 fielders are allowed to stand on leg side excluding bowler- if it's against this rule also the umpire can call as no ball

22) Teams responsible for late start of innings shall be penalized by reduction in number of overs which they will face during their innings as 15 minutes Toss-Loss, 30 mins 3 over will cut, 40 + minutes walk over. Umpires for each match should report on right time. If he is late by more than 15 minutes, 1 point shall be reduced from the teams points.

In knock out matches, If match result is a tie, the match will go to super over with one over and 2 wickets. If the result of super over is a draw the winner will be declared by toss.

23) No alcoholic drinks or such things are not allowed in the ground, and if officials find any players use such type of things while playing the whole team will be disqualified from the tournament.

24) Only 5 fielders can be allowed in the leg side field, bowler not included.

25) As Cricket is a gentlemen's game we expect all teams will show good sportsmanship to maintain the decorum of the game

26) If any team disagree their match just after getting schedule should inform tournament committee not less than 48 hours before the scheduled match time. Otherwise, it will be considered as a walk over in favor of the opposition team.

27) Umpiring Rules.

1. Its responsibility of umpire to make sure that the game is played smoothly.

2. The umpire has the right to call a bowler for chucking and doing so would result in the particular ball being declared a no-ball. Two warnings will be given to the bowler and captain. The third such call against a bowler in the entire series will disqualify the bowler from bowling another ball in the entire match.

3. Excessive sledging may result in the player being disqualified from the remaining games. The call for excessive sledging can only be made by the umpires officiating in the game who will issue a first and final warning before making the decision of disqualification after repetition of such an event.

4. Batsman can be given out by the umpire for willfully handling the ball, or willfully obstructing the field.

5. It should be made sure by that boundaries are properly marked before the match starts.

6. If there is doubt while umpiring, the two umpires should discuss the matter.

7. Umpires are not suggested to be involved in any arguments with other members.

8. The umpire can make a decision on fair and unfair play including time wasting, distracting the opposition etc.

9. Prior to the start of the match umpires along with captains must confirm players in both teams as per submitted team list to tournament committee.

28) - Captain Responsibility

Captains will be solely responsible for the conduct of the players. Players are not allowed to run on to the fields. In case of dispute only the team captain shall voice his concern.

Personal abuse against the umpires or players will not be accepted. Captains must take responsibility to mark the boundaries and middle circle before the match starts.

29) Other Consideration.

1. All matches will start at scheduled time and a match need to complete on allocated time.

2. Arguments with the umpire by any of the players/supporters of the playing teams will not be entertained under any circumstances. The team found guilty of doing this may be penalized in the form of disqualification from the tournament.

3. Players can bring friends and family members to the venues but it is requested that do not disrupt the match in anyway and refrain from using foul or improper comments that may spoil the spirit of the game.
4. In the case of any dispute, only the two captains, Umpires and the panel can involve in any sort of discussion. Umpire's and Panel's decision will be final during all matches. If any team or team member does not respect this decision, the entire team will be disqualified from the tournament .
5. Any sort of filthy language is not permitted. The batsmen, bowler, wicketkeeper and captains have the right to appeal to the umpires regarding any verbal abuse. Any other player has to make his complaint through his team captain. The umpires have the discretion to decide the validity of the complaint and arrive at a consensus giving up to two warnings to the team captain. It is the captain's responsibility to maintain the teams discipline after a warning is given.
6. No physical abuse or fights of any kind are permitted during or after the match on the field. In case of a physical altercation, the match will be abandoned and the umpires will leave the fields and make a report to the cricketing committee. The cricketing committee has the authority to (1) disqualify the team or teams responsible for the fight and (2) make a decision regarding the match points. In case of disqualification of a team from a tournament, the other teams will be awarded the points for the matches they have to play versus the disqualified team
