It has been explicitly clarified and communicated to me that there may be uncontrollable risks of transmitting or contracting **COVID-19** associated with participating in the described group event or sports activity.
- 3. I understand that I will be playing in the ground/grounds which is/are owned or maintained by **Urbana Park District** or the respective and pertinent **clubs** or **authorities.** Therefore, the organizers do not make any representations, warranties, assurances or promises regarding the condition of the ground or the ability of the organizers for this sports activity, and I voluntarily accept all risks relating thereto.
- 4. I understand the possible risks and dangers relating to the described sports activity, including risk of personal loss, personal injury, contracting **COVID-19** or even death. Although the organizers have made sure of all the necessary safety and health requirements against COVID-19 (including barring its members from shaking hands, applying saliva to the ball, wearing masks while traveling, maintaining 6-feet distance and sanitizing the cricket equipment as much as possible), **no** promises or guarantees have been made to me in this regard by any person or organizer who may be associated with the sports activity or event.
- 5. I agree to indemnify and hold the organizers harmless from any **injury or medical condition** arising from my participation in the described sports activity, whether the injury is caused by the organizers' own negligence or otherwise.
- 6. In consideration of participation in the sports activity, I hereby release, remise and forever discharge **organizers** (including but not limited to their presidents, captains, administrators, officers, and members) of and from all liability, claims, actions and possible causes of action whatsoever that may accrue to

me or to my heirs from every loss, damage/injury and infection, including death, that may be sustained by my person and property arising out of or connected with my participation in the described sports activity.

- 7. I acknowledge to the best of my knowledge that I am mentally and physically healthy and able to participate in the sports activity, without any undue or unusual risk to myself or to others.
- 8. This Waiver and Release shall be governed by Illinois substantive law and any litigation related to the enforceability of this document will be brought in the State of Illinois, County of Champaign.
- 9. The terms of this document are binding on the one signing the document, members of his or her family, and his or her spouse, heirs, assigns and personal representatives.
