Rafay mentioned some benefits received last year from City of Mississauga

- Get City Staff Liaison Hours for guidance
- Permission to use Registered Group Civic Mark
- Training for Board Members
- Rafay provided details of number of teams participating in year 2023 a total of 158 teams for summer season and 26 teams for winter season. We also conducted a successful Mayor's cup tournament on Thanksgiving long weekend where 24 teams participated.
- Scheduling was little tough due to limited slots available in Mississauga. Residents had to travel outside to play.
- We hired coop students to help us in our operational tasks.
- There were few mistakes happened in scheduling which were rectified immediately upon notice
- Zahoor presented his Vice President's report. Zahoor congratulated all board members for running a successful season despite various challenges.
- Zahoor educated teams on MCL's rules and policies.

- There were few cases about breaching code of conduct and DRC handled those cases which resulted in disqualification of few teams from playoffs and further ban few players who cheated the system.
- Zahoor brought up a feedback received from our member for not allowing a player to play in multiple teams. Discussions were open to floor to find solution to this question. There were multiple suggestions but we did not come to a logical decision, hence left the rule as is where a player from 1 club can play under their teams.
- Zahoor emphasized giving back to the community and spent many volunteering hours to plan and execute a successful summer and winter seasons.
- We spent most of the funds on cricket development and enhanced the overall cricket experience.
- We continuously finding ways to improve and provide opportunities to play 7 days a week throughout the year 365 days of cricket.
- We are promoting more engagements and promoting tourism by conducting tournaments
- Zahoor presented the Umpire Coordinator's report who was absent due to prior family commitments
- Umpire Coordinator faced challenges finding umpires and educate them at the same time
- Overall, it was a great season, we got a few new good, educated umpires. There
  was 1 incident occurred where a player got upset with the umpire on 1 decision.
  Player was given warning and penalty for misbehaving.

• Rafay moved to accept directors report. Bhupinder Singh seconded the motion.

### 9. Treasurer's report

- Mustafa presented the Treasurers report
- Mustafa went item by item on explaining the income and expenses. Comparing previous years vs current year comparison



- Mustafa stated that we did not get any funding from Cricket Ontario but still have good surplus last year
- Most of the spending was given back to the membership and cricket development
- Lots of cricketing gears and gifts were allocated for membership awards
- Cash awards were given to winners of higher division teams for cricket development
- Mustafa asked if there are any questions that required any explanation or clarification. There was no question asked but rather a positive feedback received from Imtiaz Ahmed appreciating the good gesture of spending back on the membership and on cricket development
- Rafay moved to accept the Treasurer's report, Steven seconded the motion.

- Zahoor answered that it will be minimum 4 games including rainouts
- Raja from GTA Scorpions asked about rosters carrying over from last year.
   Zahoor mentioned all teams start clean just captain and vice-captain are listed. Duplicated profiles should be notified to MCL to be merged.
- Steven asked about nets and practice pitches
- Ravi from Chennaiyian Super Kings asked about weekday games and releasing schedule. Zahoor mentioned schedule will be released before captains meeting.
- Bhupinder from Punjab CC mentioned that schedule shouldn't be changed once it's up. Eldhose from Legends Kerala agreed with this statement. Rafay explained that sometimes we do have to change the schedule due to some errors in the schedule and sometimes teams have some religious

- Zahoor introduced the Impact player rule which will replace our previous year super sub rule
