WAIVER AND RELEASE OF LIABILITY

This waiver may not be modified. Signed waivers are required to participate in OGCC events. In consideration of being allowed to participate in any way in OGCC programs, related events and activities, the undersigned acknowledges, appreciates and willingly agrees that:

- 1. I understand that the OGCC, respective city governments and school districts providing grounds used by the OGCC tournament, do not and cannot guarantee the construction, condition, or safety of the facilities or the equipment and that this release agreement is to be binding on me, my heirs and assigns.
- 2. I will comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately.
- 3. I acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury including traumatic brain injury, permanent disability and death, and severe social and economic losses which may result not only from their own actions, inactions or negligence but the action, inaction or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, I accept personal responsibility for the damages following such injury including traumatic brain injury, permanent disability or death.
- 4. I hereby authorize and give my full consent to OGCC, in perpetuity, to copyright and/or publish any and all photographs, video and/or broadcasts in which I appear while attending any OGCC event. I further agree that OGCC may transfer, use or cause to be used, photographs, video, or broadcasts for any exhibitions, public displays, publications, commercials, online streaming, art and advertising purposes, and television programs without limitations or reservations, in perpetuity.
- 5. I knowingly and freely assume all such risks, both known and unknown, even those arising from the negligent acts or omissions of others and assume full responsibility for my participation.
- 6. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, and agree to hold harmless OGCC, its officers, officials, volunteers, affiliated clubs, their respective administrators, directors, agents, coaches, and other employees of the organization, other participants, sponsoring agencies, advertisers, and, if applicable owners and lessors including city authorities, school districts of premises used to conduct the event, all of which are hereinafter referred to as "releasees", with respect to all and any injury, disability, death or loss or damage to person or property, whether arising from the negligence of the releasees or otherwise, to the fullest extent permitted by law. I will indemnify, save and hold harmless above named releasees of, from and against any loss, cost, expense, damage or liability that such releasees may incur as a result of, arising from or in connection with such claim, including without limitation any attorney's fees, or other costs or expenses or litigation.
- 7. I will comply with and be bound by the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately.

WAIVER/RELEASE FOR COMMUNICABLE DISEASES INCLUDING COVID-19

ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT

In consideration of being allowed to participate and play in the OGCC T20 cricket tournament and related events and activities, the undersigned acknowledges, appreciates, and agrees that:

- 1. The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. Attending OGCC events could increase your risk, your child(ren)'s risk, and your family's risk of contracting COVID-19. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren), my family, and I may be exposed to or infected by COVID-19 by attending OGCC events and that such exposure or infection may result in personal injury, illness, permanent disability, and death.
