- Failure to arrive for a scheduled game will result in a forfeit.
- If a team forfeits a game, or has a No show on the day, I/we will pay **R 1520.00** (our game fees + the opposition game fees)
- I/we hereby accept that in the event of non-payment of game fees and registration fees, Rebel Force has the right as per the National Consumer Protection Act to follow the necessary procedures to collect the outstanding fees.
- All preferences will be taken into consideration as best we can, but not guaranteed.
