



Ramazan T-10 Tournament Rules, Terms and Conditions

1. All teams interested in participating must fill out Team Registration, Player Information, Release of Liability, and abide by these Terms and Conditions of the tournament.
2. Entry fee per team will be \$700.
3. In addition to meeting the requirements set aside by Sacramento Premier League and AD Sports, within this document, all teams must also ensure on their own that they meet the minimum requirements set aside by local cities for the use of their facilities.
4. Teams will be required to submit a 15 person roster by the deadline of *March 31, 2018*. No changes will be allowed to the roster after the deadline has passed. Exceptions will be made only in case of injuries. Organizers reserve the right to allow roster changes at their discretion only in case of unseen emergencies and circumstances.
5. All teams will be provided with *personalized* jerseys, which will be theirs to keep. Teams will need to decide between wearing black or blue trousers, and declare their preference prior to the start of the tournament. Every member of the team must comply. Players not complying with uniform requirements, will not be allowed to play.
6. All current ICC rules of the game will apply.
7. Games will be played on the following weekends: May 19-20, May 26-27, June 2-3, and June 9-10. Semi Finals and Final will be played on the weekend of June 16-17.
8. Teams will be required to report to the ground 30 minutes prior to the start of the game. Toss will be done 15 minutes prior, and games will start on time. There will be no exceptions to this rule. It will be teams' responsibility to make sure that they arrive at the venue on time.
9. No game is to exceed the 2 hours allotted. A maximum of three (3) games could be played on a venue on the scheduled days. Games will be scheduled on these time slots: 9am-11am, 11:15am - 1:15pm and 1:30pm-3:30pm
10. Toss will only take place if both teams have their eleven playing members on the field at the given time. Any delay in the toss will result in 1 over penalty per 5 minutes of delay. After 15 minutes of delay, game will be awarded to the opposite team. If both teams fail to meet this requirement, game will be reduced to a shorter format to meet the time requirements, and both teams will be docked a penalty of 1 point.
11. Amount of Cash prizes and format of tournament will be announced once the registrations have closed.
12. Umpires' decisions will be final. Any dissent or confrontation with the game officials will not be tolerated. Umpires will reserve the right to eject a player(s) from the game, should they be deemed disrespectful towards the officials and or the spirit of the game.
13. Tournament organizers will set up the fields for all games, in accordance with the rules of the game.
14. Players, Officials and Organizers are all expected to treat everyone with respect and be good ambassadors of the sport.
15. Organizers reserve the right to add more rules to this document, should the need arise, and any such additions or changes will be done by Addendums and all participants will be notified in writing.

Release of Liability

In exchange for participation in the Ramazan T-10 Tournament organized by Sacramento Premier League and AD Sports, and/or use of the property, facilities and services of various venues where the games will be played, including but not limited to City of Sacramento, City of Davis, City of Roseville, City of Davis, City of Lodi, City of Folsom, City of West Sacramento, we, the aforementioned members of _____, agree for ourselves, and (if applicable) for the members of our families, to the following:

We agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by the organizers, or the employees, representatives or agents of Sacramento Premier League, AD Sports, Parks and Recreations Departments of respective cities.

We recognize that there are certain inherent risks associated with the above described activity and we assume full responsibility for personal injury to ourselves, our family members, and further release and discharge Sacramento Premier League, AD Sports, City and State governments for injury, loss or damage arising out of our or our family's use of or presence upon the facilities where the games will be played.

We agree to indemnify and defend City and State Governments, Sacramento Premier League and AD Sports against all claims, causes of action, damages, judgements, costs or expenses including attorney fees and other litigation costs, which may in any way arise from our or our families' use of or presence upon the facilities where the games will be played.

We agree to pay for all damages to the facilities where the games will be played, caused by any negligent, reckless, or willful actions by us or our families.

Any legal or equitable claim that may arise from participation in the above shall be resolved under the applicable existing local city, state or federal laws.

We agree and acknowledge that we are under no pressure or duress to sign this Agreement and that we have been given a reasonable opportunity to review it before signing. We further agree and acknowledge that we are free to have our own legal counsel review this Agreement if we so desire. We further agree and acknowledge that Sacramento Premier League and AD Sports have offered to refund any fees we have paid to participate in the tournament if we choose not to sign this Agreement.

This Agreement and each of its terms are the product of an arms' length negotiation between the Parties. In the event any ambiguity is found to exist in the interpretation of this Agreement, or any of its provisions, the Parties, and each of them, explicitly reject the application of any legal or equitable rule of interpretation which would lead to a construction either "for" or "against" a particular party based upon their status as the drafter of a specific term, language, or provision giving arise to such ambiguity.

The invalidity or unenforceability of any provision of this Agreement, whether standing alone or as applied to a particular occurrence or circumstance, shall not affect the validity or enforceability of any other provision of this Agreement or of any other applications of such provision, as the case may be, and such invalid or unenforceable provision shall be deemed not to be a part of this agreement.

The parties will attempt to resolve any dispute arising out of or relating to this Agreement through friendly negotiations amongst the parties. If the matter is not resolved by negotiation, the organizers of the tournament shall have the final say.

Any controversies or disputes arising out of or relating to this Agreement will be submitted to mediation with any statutory rules of mediation. If mediation does not successfully resolve the dispute, then the parties may proceed to seek an alternative form of resolution in accordance with any other rights and remedies afforded to them by law.
