**Event:** Cricket League and other competitions for 2021 ("Event") organized by the British Columbia Mainland Cricket League ("BCMCL"). In consideration of the BCMCL accepting me as a playing member of the League to participate in the Event, I, for myself, my heirs, executors, administrators and assigns WAIVE any claims to which I may become entitled for injury or damage and HEREBY RELEASE THE BCMCL and all the umpires and participants in the Event and all other organizers, sponsors, representatives, agents, employees and any other person or organization assisting in this Event from any claims for damages or injuries suffered to me as a result of my participation in the Event including conditions of the pitch and the field, whether or not caused by negligence and/or howsoever caused including recklessness or omission of any such parties.

I understand that there are inherent and other risks involved in the Event and injuries are a common and ordinary occurrence and I freely assume those risks and accept full responsibility for any and all such damage or injury which may result. I am advised to wear all the protective gear for my protection and safety while playing in the Event and I further state I am in proper physical condition to participate in this Event and I am aware that my participation could, in some circumstances, result in physical injury. BCMCL reserves the rights to accept, renew or terminate your membership including during the season in the event of breaching its By-Laws, rules and policies as per details on [bcmcl.ca](http://bcmcl.ca). *Players who are not covered with valid MSP (Medical Services Plan) coverage or similar private medical insurance, will not be covered by the BCMCL Insurance.* I, the undersigned have read and understood the terms and conditions of this waiver/release BCMCL's code of conduct, By-laws, social Media, Privacy, Communications and Insurance policies as per details available on [www.bcmcl.ca](http://www.bcmcl.ca)

Junior players under 19 years of age may play for any club in the BCMCL with express permission from their own club. This waiver covers all BCMCL events regardless of which club a junior may be playing for.

**WAIVER/RELEASE FOR COMMUNICABLE DISEASES INCLUDING COVID-19:**

In consideration for playing Cricket related activities at BRITISH COLUMBIA MAINLAND CRICKET LEAGUE (BCMCL) (hereinafter the "Activity or Activities"), I, on behalf of myself and any minor child/children for whom I have the capacity to contract, hereby acknowledge and agree to the following:

1. I understand the hazards of the novel coronavirus ("COVID-19") and am familiar with the Centers for Disease Control and Prevention ("CDC") guidelines regarding COVID-19. I acknowledge and understand that that the circumstances regarding COVID-19 are changing from day to day and that, accordingly, the CDC guidelines are regularly modified and updated and I accept full responsibility for familiarizing myself with the most recent updates.

2. Notwithstanding the risks associated with COVID-19, which I readily acknowledge, I hereby willingly choose to participate in Activities.

3. I acknowledge and fully assume the risk of illness or death related to COVID-19 arising from my being on the premises and participating in the Activities and hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE (on behalf of myself and any minor children from whom I have the capacity contract) BRITISH COLUMBIA MAINLAND CRICKET LEAGUE (BCMCL), their officers, directors, agents, employees and assigns (the "RELEASEES") from any liability related to COVID-19 which might occur as a result my being on the premises and participating in the Activities.

4. I shall indemnify, defend and hold harmless the RELEASEES from and against any and all claims, demands, suits, judgments, losses or expenses of any nature whatsoever (including, without limitation, attorneys' fees, costs and disbursements, whether of in-house or outside counsel and whether or not an action is brought, on appeal or otherwise), arising from or out of, or relating to, directly or indirectly, the infection of COVID-19 or any other illness or injury.

It is my express intent that this Waiver and Hold Harmless Agreement shall bind any assigns and representatives, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE the above-named RELEASEES. This Agreement and the provisions contained herein shall be construed, interpreted and controlled according to the laws of the British Columbia. I HEREBY KNOWINGLY AND VOLUNTARILY WAIVE ANY RIGHT TO A JURY TRIAL OF ANY DISPUTE ARISING IN CONNECTION WITH THIS AGREEMENT. I ACKNOWLEDGE THAT THIS WAIVER WAS EXPRESSLY NEGOTIATED AND IS A MATERIAL INDUCEMENT THE PERMISSION GRANTED BY RELEASEES TO BE PLAY AND PARTICIPATE IN THE CRICKET RELATED ACTIVITIES.
